

2015-2016 Dependent Student Verification Worksheet

Your 2015–2016 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. Regulations stipulate that before awarding Federal Student Aid, we may ask you to confirm the information you reported on your FAFSA. A comparison will be made with the information from your FAFSA, this worksheet, and any other required documents. If there are differences, your FAFSA information may need to be corrected. You must complete and sign this worksheet, attach any required documents, and submit the form and other required documents to the financial aid office. We cannot process your financial aid until verification has been completed. Please provide the required documents as soon as possible, so that your financial aid will not be delayed.
