Your 2014-2015 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. Your school may ask for additional information. If you have questions about verification, contact your financial aid administrator as soon as possible so that your financial aid will not be delayed. If more space is needed for any section on this form, attach a separate page with the student's name, Student ID Number or Social Security Number indicated clearly at the top of the page.
