Student Equity 2.0 Approach to the Data

Our approach was informed by our commitment to take action and responsibility for inequities experienced by racially minoritized student populations at our colleges.

The workgroup focused on disaggregated data that

- Support alignment with Guided Pathways and Vision for Success
- Raises awareness and helps colleges prioritize actions that serve student populations experiencing the disproportionate impact at the colleges
- Are accessible to all colleges via the dashboard, data-on-demand files, or local data to strengthen their ongoing capacity-building efforts.

- Builds on what we have learned over the last eight years of designing and implementing student equity efforts across the community college system,
- Emphasizes a race conscious approach to student equity and guided pathways
- Fosters active collaboration and integration between student equity and guided pathways
- Takes a community-oriented approach to addressing the challenges faced by campuses when trying to develop and implement race-conscious equity efforts
- Leverages the experience and expertise of community college leaders to create conversations, communities of practice, tools and curriculum over the next year
