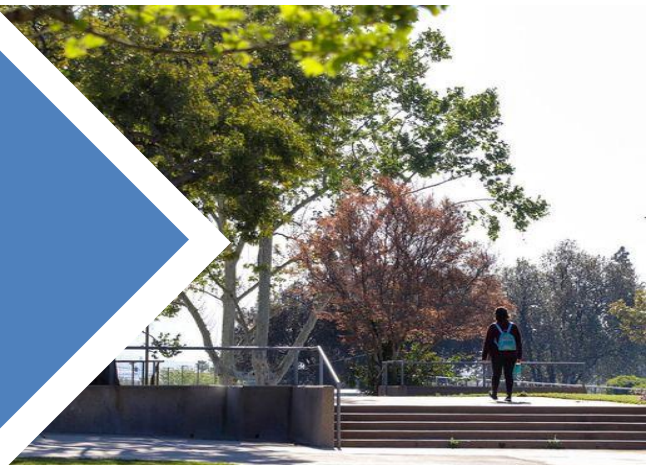

Summary of Activity:

The Curriculum Committee was very active in the 2022 – 2023 academic year. We learned a new curriculum management system, CurrIQunet Meta, affectionately called “Meta.” We know that many faculty are acclimating to the new system, and we want to remind them that we are here to help. Please reach out if you have any questions. We started working on best practices and sample answers for questions in Meta, knowing that sometimes it is difficult to answer these questions without a prompt. We hope to complete this project in the fall semester.

Also remember that it’s important for departmental faculty, especially full-time faculty to participate in the curriculum process. This includes discussing curriculum – both new and content review – in department meetings, reviewing course content with colleagues, and leaving comments in Meta for the Curriculum Committee to make informed decisions. We rely heavily on you to support our students through curriculum.

There is a lot of legislation that affects the Curriculum Committee and its work. We anxiously await updates from the State Chancellor’s Office related to AB 928 and AB 1111.

- AB 1111: Common Course Numbering (CCN)
 - CCCCCO CCN Task Force plans to develop a recommended implementation plan for CCC’s by Dec. 2023
 - Next webinar: June 22, 2023
- AB 928: Cal-GETC, a singular GE pattern
 - A framework was released by the [Intersegmental Committee of Academic Senates \(ICAS\)](#) on 2/1/23. While a general framework was released, the details of that framework are not yet known. We want faculty in the affected disciplines to know that while we may not have all the answers yet, we will ensure that their voices are heard and that they have representation when work is being done for the local GE pattern. Please review the email sent from Davena Burns-Peters on 2/27/23 with the current updates on AB 928 and its effect on SBVC.
 - In addition, on 12/12/22 the Curriculum Committee approved a framework for an AB 928 Steering Committee and an AB 928 ad hoc workgroup to address the effects of AB 928 at SBVC.
 - This committee structure was [unanimously approved by the Academic Senate on 2/1/23 \(motion 2\)](#). We requested the following committee membership makeup and await a decision from the Academic Senate to officially assign faculty to both the steering committee and the ad hoc workgroup. Our goal was to first meet during the spring 2023 semester; however, it is more likely that we will meet for the first time during the summer in order to plan for the 2023 – 2024 academic year.

We reviewed curriculum and a program map for the Baccalaureate degree in Water Resource Management (WRM). The committee was very flexible and responsive to this new degree. We even held a special meeting during convocation week to finalize approvals for the curriculum and program map, in concept. We are especially grateful to Melita Caldwell-Betties and her team for her hard work. While the outcome may not have been what we hoped for, we are still proud of all the work the committee did. We will look forward to re-submitting the program to the state.

We are grateful to Dr. Anthony Blacksher for his work writing new Ethnic Studies courses, which will become effective fall 2024:

- ETHS 104: Introduction to Latina/o/x Studies
- ETHS 105: Introduction to Asian American Studies
- ETHS 106: Introduction to Black Studies

Our students need these courses to graduate, due to legislation mandating Ethnic Studies courses as graduation requirements. Dr. Blacksher worked expeditiously to create new courses and Janice is monitoring their articulation status. We also collaborated with Dr. Blacksher on recommended language for AP 4020 that specifically addressed Ethnic Studies requirements.
