How we got here...

Policies for consistency to award Military personnel and Veterans college credit from based on their JST's

ASCCC Resolution 18.04 (2011)

Urges local academic senates to apply credit for educational experiences during military service toward the associate degree — including the fulfillment of general education, major coursework, certificates, and other degree requirements — in accordance with the recommendations listed in the *American Council on Education (ACE)* Guide to the Evaluation of Educational Experiences in the Armed Services.

2018 Cervantes AB 1786

 Academic Credit for Military Experience: Specified that by March 31, 2019, the CCC Chancellor is to establish an initiative to expand military Credit for Prior Learning (CPL).

2018 Roth CA S 1071

 Community Colleges Uniform Policy to Award Credit: Requires CCC Chancellor to work with Academic Senate for California Community Colleges (ASCCC) to develop a consistent policy to award military personnel and Veterans who have an official Joint Services Transcript course credit for Intersegmental General Education Transfer Curriculum, State University General Education Breadth or local comm general education requirements.



 What is MAP (Military Articulation Platform)?

 MAP is a collaborative effort enjoined by the Academic Senate of the California Community Colleges (ASCCC), the CCC Chancellor's Office (CCCCO), ACE, CalVet, and local and regional legislators

- What is the CPL (Credit for Prior Learning) Initiative?
 - CPL is a collaborative effort enjoined by the Academic Senate of the California Community Colleges (ASCCC), the CCC Chancellor's Office (CCCCO), ACE, CalVet, and local and regional legislators.

(AB1786) requires an initiative to expand the use of course credit at the California Community Colleges for students with prior learning.

MAP/CPL and AP 4235

Students may demonstrate proficiency in a course eligible for **Credit for Prior Learning** and receive college credit through the approved alternative methods for awarding credit listed below:

Achievement of a score of 3 or higher on an Advanced Placement Examination administered by the College Entrance Examination Board.

Achievement of a score that qualifies for credit by examination in the College Level Examination Program (CLEP).

Evaluation of joint service transcript (JST) that considers the credit recommendations of the **American Council on Education (ACE)** pursuant to Education Code 66025.71.

The American Council on Education (ACE)

ACE is the nation's unifying voice for higher education and serves as an agency to provide credit recommendations based on peer reviews analysis for educational training.

AP 4235 already recognizes ACE's recommendations pursuant to Education Code 66025.71

Get involved and apply to be an ACE faculty reviewer here For Faculty (acenet.edu).

ACE faculty requirements

- Must be currently teaching at accredited college or university
- Reviews are based off academic discipline alignment (subject-matter experts)
- Minimum 5 years of experience to quality
- ACE evaluations are rigorous and hands-on
- Faculty review and approve all recommendations for credit and mjust be at 100%

General CPL and AP 4235

Evaluation of industry-recognized credential documentation.

Evaluation of student-created portfolios.

Credit by satisfactory completion of an examination administered by the college in lieu of completion of a course listed in the college catalog.

Achievement of an examination administered by other agencies approved by the college.

Assessment approved or conducted by proper authorities of the college.

The relationship between MAP & CPL

- ▶ JST's (Military Transcripts) are evaluated first by evaluators, then by counselors to determine <u>possible credit</u> for courses within the students' education plan, and then approved (or denied) by the department chair (or designee). If approved, transcription is done by evaluators. The articulation officer gets involved if there are problems
- This process has been systematized within the MAP (Military Articulation Platform) software.
- We are 1 of 76 of the 116 CA Community Colleges that are utilizing MAP.

- General CPL is less defined.
- Grant funding for CPL and Competency Based Education (CBE)
- Two year goal:
 - ▶ 20 mapped CTE courses
 - 20 courses cross listed
- Our campus has an opportunity to define what that looks like for us.
