### President's Update – Area Meetings, Spring 2024

#### Faculty Empowerment Leadership Institute

- Eight mentors and twelve mentees (34 mentee applicants)
- 1<sup>st</sup> convening in December, 2<sup>nd</sup> next week
- Look for mentor recruitment at end of Spring semester and mentee applications by early fall

#### Curriculum: 5C

- DEIA in COR regulations under development
- PCAH updates
- Drafting baccalaureate degree regulations to replace BDP Pilot Program Handbook

#### FLEX Regulations and Handbook

- Chancellor's Office workgroup reviewing existing handbook and regulations
- First meeting mid-March. Intention to propose updates by end of Spring 2024

#### Cal-GETC: Standards version 1.1 document (Dec 2023)

- ICAS Cal-GETC Standards Subcommittee meeting now as part of regular review cycle. Accreditation, CLEP, GPA, have all been part of conversation
- UC, CSU, CCC System office leadership meeting to discuss submission and review processes. Memo forthcoming

#### ASCCC Transfer Alignment Project

- Prior efforts to align TMCs with UCTPs.
  - Aligned: Sociology and Political Science.
  - Likely alignment: Anthropology and History
- Current efforts to align STEM TMCs with UCTPs and with addition of 6 additional units consistent with December 2023 AB 928 Committee recommendations
  - Discipline Input Groups (DIGs) being held in March and April in STEM disciplines: Biology, Chemistry, Computer Science, Engineering, Mathematics, Physics
    - Math and Physics already convened. Based on input received, draft TMC to be vetted with discipline faculty of CCC, CSU, and UC during Spring 2024

#### Model Curriculum Workgroup

- Exploring opportunities to facilitate development of model curriculum to support system needs as well as emerging courses and programs

- Modern Policing Workgroup developing model curriculum during Spring 2024 based on requirements of AB 89 and [October 2023 recommendations of AB 89 Task Force](#)
- Potential development of curricular crosswalks in select apprenticeship programs as part of Vision 2030 Apprenticeship Demonstration Project

#### Baccalaureate degrees (AB 927, 2021)

- Cycle 2 and 3 programs with duplication objections from CSU still being resolved
- Key: do not duplicate CSU programs. Also, make sure upper division coursework reflects the advanced critical thinking and rigor expected of upper division courses.
- In December, ICAS made recommendations re: duplication review processes to CCC and CSU Chancellor Offices. CSU & CCC system offices have incorporated recommendations and continue to refine duplication review processes, particularly for cases of duplication objection.
- Cycle 4 submissions in January. Applications have been reviewed and scored. Chancellor's Office will convene readers in April for follow-up discussion.

#### Common Course Numbering Council (AB 1111, 2021)

- [Final report released](#) in January
- [Common Course Numbering Council](#) and workgroups have started meeting
- Chancellor's Office request of legislature to extend legislated timeline to July 1, 2027
- Council just notified of first 6 courses for descriptor development, starting with existing C-ID descriptors, based on past enrollment data. The six highest enrolled courses, with 1,064,895 enrollments in 2022-23 are:
  - ENGL 100 College Composition
  - ENGL 105 Argumentative Writing and Critical Thinking
  - COMM 110 Public Speaking
  - MATH 110 Introduction to Statistics
  - POLS 110 Introduction to American Government and Politics
  - PSY 110 Introductory Psychology
- Plans are being developed to convene CCC, CSU, and UC faculty in these disciplines in late spring or early summer. More info to come as it's available.

### Chancellor's Office Universal Design for Learning Task Force

- Task force started meeting in late October and has developed a preliminary set of recommendations that being vetted with participating groups, including ASCCC
- Intent of Chancellor's Office is to better clarify and support expectations of and actions toward student-centered accessibility as interwoven into the operations of campuses
- Manuel Vélez, ASCCC Vice President, is a co-chair

### ASCCC-OERI and ZTC

- [ASCCC Open Educational Resources Initiative \(OERI\)](#)
- Look under Resources at [www.asccc-oeri.org](http://www.asccc-oeri.org) to see collections of resources available, organized in multiple ways including by discipline and by general education area
- The OERI is presently in the process of holding the initial meetings of the 28 ZTC Collaboration Cohorts identified by the CCCCO to ensure that there is no "duplication of effort" among the colleges that are working on ZTC pathways.
  - The OERI is working with discipline faculty to facilitate conversations with the cohort members that provide an overview of available resources for getting courses to ZTC and the status of those courses at the cohort colleges.
  - By the end of March, seven cohorts will have been convened and all cohorts will have their initial convening scheduled.
  - During the 1st meeting, the cohort determines how to proceed, often opting to divide the cohort into course-based sub-groups. The OERI will soon begin to share the information gathered from the cohorts.

- On-going OERI webinars. Additional webinars have been scheduled based on needs and trends observed in the information provided by the cohort colleges.
- Chancellor's Office has released early information about additional ZTC funding opportunity in April.
  - Colleges will be able to apply for up to \$200,000 per eligible program through Acceleration II or Impact Grants and up to \$20,000 per eligible course for OER Expansion Grants.
  - A Chancellor's Office memo with additional details, including eligibility criteria, timelines, and reporting requirements is forthcoming.
  - ASCCC OERI will continue to partner with the Chancellor's Office and colleges in support of these grants.

### Generative Artificial Intelligence

- ASCCC partnered with Chancellor's Office and FACCC. Three webinars completed, fourth on April 30. Recordings available in Vision Resource Center.
- ASCCC Education Policy Committee developing AI policy considerations in response to [Resolution 13.05 \(Spring 2023\)](#). See agenda for April Executive Committee meeting, plus join us at Plenary Session

- Chancellor's Office intention to develop guidelines for Board of Governors review in July 2024. ASCCC will provide leadership for AI in Teaching and Learning, will collaborate with faculty organizations and statewide faculty

#### Governor's Master Plan for Career Education

- Governor Newsom Executive Order N-11-23 calls for development of master plan by October 1, 2024
- Philosophy of Governor's Office: all education is career education
