➤ A. Hecht welcomed six newly elected adjunct faculty members to the Academic Senate, each representing various departments, and also introduced Alaysha, the VP of Student Senate. She announced her transition to a non-voting co-chair role on College Council, with Keynasia Buffong representing non-instruction with the purpose of being intentional as this is one of Valley Up Initiatives. A. Hecht shared that several faculty members, including Thomas Berry and Brenda Orozco, will be attending and presenting at the upcoming ASCCC Fall Plenary (Nov. 6–8), with one more participant pending budget approval. She proposed drafting a standing rule on meeting norms and introducing a new Treasurer position in the Senate bylaws to help manage their newly allocated \$25,000 annual budget, a first for the Senate. Lastly, she announced that Asian American and Native American Pacific Islander Serving Institutions Program Week will run from September 22 to

i) Curriculum, Thomas Berry (3 minutes)

➤ T. Berry provided a comprehensive update on curriculum, focusing primarily on the Common Course Numbering (CCN) project. Phase 2b is wrapping up with a final faculty workshop tomorrow, followed by tech review on October 13 and full committee review on October 20, aiming to get the courses on the December board docket. Berry emphasized that SBVC's approach—adding templates without altering faculty-approved content—has led to smooth approvals statewide, unlike some colleges facing rejections. Phase 3 of CCN is expected to begin in spring, with a significantly larger volume of courses, including honors and lab sections. He also noted the ongoing development of

the bachelor's program, which is moving toward final approval and transition to Student Services for implementation. Additional updates included clarification on prerequisites in CCN templates, progress on the class caps list in coordination with the VPI, and the launch of Meta office hours to support faculty with curriculum-related questions. ➤ A. Nash reported on updates from Associated Student Government (ASG), sharing that the student senate is still expanding. She encouraged faculty to recommend students who may be strong leaders. ASG is working on several initiatives, including adulting workshops on topics like taxes and renting, revising their constitution with student involvement, and increasing outreach through panels and forums to demystify ASG and boost engagement. They've also formed a Research, Planning, and Resolution Committee to support event planning and prepare resolutions for statewide advocacy. Other goals include developing a campus garden, launching a Spirit Team, and encouraging student participation in all efforts.

This effort aligns with participatory governance goals, aiming to ensure consistent representation and information sharing. They hope to have a classified liaison attend Senate meetings and invite the Senate to send a liaison to their meetings as well. Additionally, they announced that volunteers are needed to help with the football game concession stand, and anyone interested—classified or not—can contact John Feist to participate. The group appreciates the ongoing collaboration that ensures classified professionals have a voice and are recognized in these spaces and look forward to being involved and exploring ways we can work together moving forward.

h) President, Gil Contreras (3 minutes)

- G. Contreras shared several campus updates, starting with appreciation for student leadership, particularly ASG, for their engagement and events like Pizza with the Presidents. He highlighted the importance of faculty chairs in ongoing initiatives such as the Valley Up strategic focus and committee restructuring, and expressed interest in recognizing their contributions. Last Friday, Congressman Pete Aguilar visited the Applied Technology Building, supporting programs like the PV trucks project. G. Contreras acknowledged the kickoff of Hispanic Heritage Month and HSI Week, thanking the HSI Task Force for their efforts. Upcoming events include Poncho Sanchez's performance on October 12 and ongoing flyovers with the Aeronautics program. He encouraged everyone to stay informed on College Council discussions, including upcoming reorganization concepts and recruitment updates. On the BookSaver program, a recent informal survey showed mostly

Hecht will work on Membership, Thomas, Bethany, and Danny on Organization, and A. Hecht will likely revise the Amendments section.
