Hecht - thanked colleagues for their support and reflected on her decision not to run again for president, noting the role was demanding but meaningful and built on collective work. She emphasized progress in transparency, collaboration, and helping faculty better understand the purpose and power of the Academic Senate. Despite facing challenges last year, she remained committed to learning best practices, addressing past practices, and clearly communicating the reasons behind institutional decisions.</p> <p>➤ She highlighted her commitment to representing underheard voices, particularly counselors and librarians. She discussed longstanding concerns about counselors being placed on repeated temporary full-time contracts and expressed appreciation for progress made under Dr. Contreras to move counselors into permanent positions. She noted continued efforts to advocate for increased librarian faculty as well.</p> <p>➤ Another key goal was leadership development. She encouraged faculty participation in plenaries and governance, explaining that stepping down was</p>

A special meeting or first read during convocation week may be scheduled to move the process forward.</li><li>■ Some senators expressed concern about rushing the process during Flex/convocation, emphasizing that meaningful faculty and student feedback requires alignment with the academic calendar. Members noted that the Senate's meeting schedule is published well in advance and that district and PPAC timelines should align with Senate processes, not the reverse. Concerns were also raised that significant Senate feedback provided in May had not yet been addressed and that <a href="#">PPAC</a> began work late.</li><li>■ The consensus shifted toward not adding an extra meeting during convocation week and instead requesting that the district hold off on moving the policies forward until February. - He provided updates from the *Wolverine Weekly*, including plans for a spring mural project in collaboration with the San Bernardino Center for the Arts. The project will move through participatory governance and include input from students and alumni. He also shared ideas from *Coffee with the Cabinet*, including interest in reviving a campus fitness club or challenge, which will be explored in the spring.
- He reminded faculty of the upcoming holiday gathering on Friday, featuring raffles and fundraising for student scholarships. Additionally, he announced that the campus Communications Department will be relocated to the Administration Building, occupying the former STAR Center space, to better centralize the President's team and enhance campus promotion ahead of future student center development.
- He concluded by wishing everyone a successful end to the semester, timely grading, a restful holiday break, and expressed enthusiasm about celebrating together at the holiday event.

<p>detailed timeline. Two proposals were developed, and the final proposal—incorporating more than 30 changes to the organizational chart based on feedback from faculty and other constituent groups—was presented at the previous Senate meeting.</p> <p>➤ He expressed optimism about the revised proposal, emphasizing that it reflects broad input and represents a significant improvement over the initial draft. The proposal is scheduled to move forward to College Council on Wednesday, December 10, with the hope of faculty support.</p> <p>➤ It was clarified that no changes were made between the first and second reads. The item proceeded as a second read, requiring a motion to either support or not support the Stage Three Reimagining proposal. A motion of support was made and seconded.</p> <ul style="list-style-type: none"><li>■ M. Notarangelo shared that early drafts of the reorganization included changes that would have negatively affected their ability to serve the campus. They appreciated that two major concerns were addressed in revisions, including restoring the library as an independent division and aligning library technology under the same dean. However, serious concerns remain regarding the loss of administrative leadership and funding, including the elimination of a director position and the reclassification of the dean to an associate dean. Faculty emphasized that the scope and impact of library services require full dean-level leadership and urged continued discussion around restoring leadership capacity.</li><li>■ F. Gonzalez shared concerns within their division regarding naming and structure to “Career Technical Education,” the division ultimately agreed to align with systemwide community college terminology.</li></ul>	<p>2nd: P. - Additional concerns were raised about the proposed Instructional Support Services Division, which was described as overly “hodgepodge” and driven by workload considerations rather than student needs. Speakers emphasized that divisions should be structured based on educational coherence and expertise, trusting faculty who work in those areas to guide appropriate organization.
- b) Revised Academic Senate Committee Structure, Jeremiah Gilbert and Tatiana Vasquez (discussion, 10 minutes)
  - ❖ NOTES
    - T. Vasquez and J. Gilbert provided an update on the ongoing development of a revised [Academic Senate Committee Structure](#), initially discussed on November 19. The purpose of the discussion was to gather feedback on the document’s intent and impact, not to conduct a formal second read. Faculty input is being sought to ensure the document reflects shared priorities, incorporates survey data, and clearly defines the Senate’s role, structure, and operational cycle. A finalized version is expected for first and second readings in February.
    - One focus was the evolving scope of program review, which has increasingly become a catch-all process extending beyond its original instructional focus and potentially beyond the Senate’s 10+1 responsibilities. Similar issues were noted for accreditation and professional development, which involve faculty and Senate input but also extend beyond faculty-specific concerns. The discussion emphasized the need to clarify committee roles, reporting structures, and governance processes to ensure meaningful Senate involvement while supporting broader institutional effectiveness. Ongoing work with the Program Review Committee and participatory governance efforts will inform final recommendations.

- A. Avelar provided historical context on program review, explaining that it was once **punitive**, with programs subject to hiatus or discontinuance if they did not meet standards. This system aimed to ensure accountability and keep curriculum, especially CTE programs with two-year review cycles, up to date. However, it created challenges when only a few faculty had the necessary expertise, sometimes putting programs at risk of removal, as in the case of HVAC programs in Southern California. Over time, to maintain accountability and prevent programs from bypassing oversight, all curriculum and program matters were routed through program review, which now serves as the central mechanism for faculty oversight and curriculum management.
- T. Vasquez and J. Gilbert discussed proposed changes to committee reporting structures under the Academic Senate. They suggested renaming Professional Development to Faculty Development to clarify its focus on faculty. Other committees mentioned include the Honors Committee, Distance Education (currently outside Senate reporting, proposed to report to Senate), Chairs Council (which could improve communication and early issue resolution), and Dual Enrollment (potentially as a task force or Senate committee). The presenters emphasized that the discussion extends beyond program review, highlighting the need to consider all committees that should fall under Academic Senate oversight to enhance communication and governance.
- B. Tasaka provided clarification on the current approach to program review, emphasizing that it is now a self-evaluation process rather than a punitive evaluation of instructional or non-instructional areas. Committee members review self-evaluations collectively, and the structure allows areas to voice what is and isn't working. While the committee is open to expanding membership, Tasaka cautioned against splitting responsibilities

in ways that could lead to inconsistent practices. She noted that the current approach represents a significant shift from previous practices, promotes faculty and staff agency, and supports constructive discussion. Feedback from colleagues is encouraged to ensure the process continues to improve and meets the needs of both faculty and students.

- A. Mills provided clarification regarding the Honors Committee, noting ongoing confusion about its status. The Honors program is no longer a committee but functions as a program under Transfer with faculty leads, coordinated by a designated coordinator. The coordinator manages the responsibilities outlined in the committee handout, which are accommodated within their release time. A. Mills suggested that the workload does not justify frequent biweekly or monthly committee meetings and recommended that the coordinator determine the appropriate meeting frequency, noting that the program may function more appropriately as a task force rather than a standing committee.
- J. Lemieux commented on the scope of the Program Review Committee, emphasizing that its focus should remain on faculty-related programs, which aligns with the Senate's 10+1 purview. For non-faculty programs, such as groundskeeping, Lemieux suggested that a campus-wide committee reporting to College Council would be more appropriate, as administrators or broader constituency representation would have more expertise. This approach would ensure that program review remains accurate and effective while keeping faculty oversight focused on areas where their expertise is strongest.
- T. Vasquez and J. Gilbert provided clarification on the Honors Program and Honors Committee, emphasizing that the program is already under evaluation and functions as a program with a designated faculty lead, while the committee

serves an advisory and oversight role. The committee would provide faculty the opportunity to discuss course offerings, honors contracts, equity issues, and collaboration with instructional faculty, helping ensure students can complete the program successfully. Feedback from faculty was solicited regarding the committee's structure, responsibilities, and relationship with other roles such as department chairs. The presenters also discussed other committees, including Dual Enrollment, Faculty Development, and Distance Education, recommending placement under Academic Senate where appropriate, and suggested that concrete decisions regarding charges, responsibilities, membership, and committee assignments be addressed at the first read in February.

c) Student Equity Report, Carmen Rodriguez (2nd read, 10 minutes)

❖ NOTES

➤ C. Rodriguez reported that the second reading of the [Student Equity report](#) for 2025–2028 shows no changes to the metrics, though the document has been elaborated and remains a live document that can be updated. The report focuses on five key metrics: successful enrollment or teacher transfer level, math and English completion, Vision goal completion, and transfer to four-year universities. Key strategies from the Student Equity Fund are being implemented, with an additional strategy added to improve transparency and opportunity across the campus. Students have been included on a committee to ensure their voices are heard, and student focus group sessions, starting with math and English, are tentatively scheduled for February. Progress will be shared with the Academic Senate, classified staff, ASG, and at divisional, instructional, and student services meetings. The goal is to provide the campus community with data dashboards, track what has changed or not, and identify next steps to close equity gaps.

- A. Mills - Since you mentioned math and English in particular, when you advertise for focus groups, how do you reach out to faculty?
  - We will work directly with the English and Math department instructors. The plan is to conduct the focus groups in person and also use surveys. We'll coordinate with Institutional Research (IR) to manage the process. Faculty will be informed so they can encourage student participation, possibly offering extra credit. Students will provide their student ID numbers, which will be collected by the instructors to ensure proper tracking.
- T. Vasquez - Could you help me understand what kind of information the students will provide in the focus groups?
  - We will develop specific questions and prompts with the committee and faculty members. Students will share what has helped them succeed and what barriers they face in completing courses like Math 102 or English within a year. The focus groups will target students who have not yet passed English or math, as well as those currently enrolled. We'll start with math and English but plan to expand to all students.
- T. Vasquez - How will faculty be involved?
  - Faculty members from the Student Success Advisory Committee will help develop the questions. Ideally, we will have at least one faculty member from each discipline to ensure all student segments are represented. While faculty may sometimes attend focus groups, students will also have private opportunities to speak honestly about their experiences. The feedback will then be shared with faculty to identify barriers and improve support.
