# **CLASSIFIED SENATE MEETING MINUTES**

Call to Order: The meeting began at 12:38 p.m.

Roll Call: See attached.

<u>Approval of Agenda</u>: John Feist motioned to approve the draft agenda; Michael Gonzales 2<sup>nd</sup> the motion. Approved by general consensus.

Approval of Minutes: Minutes from April 24, 2020 were tabled for the next meeting.

**Public Comment/Guest**: Tentative, Yash Patel, Sustainability Plan—Did not attend, tabled for next meeting.

Diana Rodriguez, SBVC President, attended the meeting as a guest. She shared a few items with the Classified Senate. Diana also gave a "thank you" to all classified professionals for what they do for SBVC—we are the backbone and are tied to student success. She talked about classified professionals' week, and due to the pandemic, the executive team wants to support staff in what they would like to do—BBQ, late fall/spring—virtual—or something extra special when we return to work. She mentioned the all-campus meetings, noting if classified staff have any specific issues, to sent them to her via email or text.

#### Reports:

A. <u>President:</u> Ernie Guillen is acting President in Judy Rodriguez' absence. He noted the board meeting; he gave an update on classified professional activities; reviewed the statement of support for student trustees and voting privileges; he further noted that SBVC is going to the 4/10 work schedule effective the first week in June—there were inquiries on this schedule due to remote working from home. Ernie proposed to contact HR about sending a notice to the managers. There was discussion on what a senator does as part of the Classified Senate, as well as how many senators are needed per number of employees and how senators are allocated to various work areas. Ernie will also see about setting a meeting to meet with the president.

B. <u>Treasurer</u>: Phylicia Sanchez said there were not many changes to the budget from the last meeting.

C. <u>CSEA:</u> Ernie Guillen mentioned a vote the union was holding; CSEA still holding Friday cyber meetings—social hour. Mary Valdemar mentioned a community food bank event and as the PAC member, reminded classified staff that there are several board member seats coming up for reelection.

## D. Others:

- <u>Accreditation</u>: Dena Peters mentioned the importance of classified staff participating in the accreditation process as part of shared governance—ref. the institutional selfevaluation report (ISER) that is available for review and feedback.
- <u>District Assembly</u>: Girija Raghavan is part of the District Assembly, and she attended the last meeting; the topic discussion was the budget scenario—there will be a study session next week, and she encouraged all who can attend to do so . . . there is a Zoom link for the meeting.

## New Business:
