## CLASSIFIED SENATE MEETING MINUTES

Friday, May 30, 2014

1:30-3:00 p.m. - AD/SS-207

1. Opening: President Thomas called the meeting to order at 1:45 p.m.

#### 2. Roll Call:

- 3. Approval of Agenda: The agenda was approved with public comment moved up to be discussed first to accommodate the speaker, Rose King 1<sup>st</sup>, Aaron Beavor 2nd. Approval is unanimous.
- 4. Approval of Minutes: The minutes for the April 18, 2014 meeting were approved, Aaron Beavor 1<sup>st</sup>, Mary Valdemar 2<sup>nd</sup>. Rose King abstained. (President Thomas will check on the allocation split discrepancy, as she has since seen slightly different amounts mentioned.)
- 5. <u>Public Comment/Guest:</u> Sarah Miller recommended that we oppose the recommendations of the College Brain Trust, and the long range staffing plans, for these reasons:
  - The comparison colleges that they gave are not comparable colleges.
  - There is no explanation of why our security/police staff is high. San Bernardino city has a high crime rate, and this should be acknowledged as an important reason for why we need more security and police staffing.
  - There is no realistic comparison of students. They only compared the number of students, not the type of students at the colleges.
  - Staff are already overworked as it is, and many staff believe that compared to
    other colleges, our work load is greater, and our pay is less, so reducing staff
    would only add to this. A good staffing plan would show how we could improve
    our services to students with long term goals that take time to develop.
  - It is not right that staffing positions would be cut back to save money, but then it is recommended that 2 high level positions would have their salaries increased. Staff should be treated with more consideration than this.

The report itself is of poor quality. It is poorly researched and developed. When
the report is thoroughly examined, it is easy to see that it is not a well documented and factually supported report.
