New Business	<p>Reading & Study Skills Department Discussion - Kimberly Jefferson is requesting that the Committee reinstate the Education (EDUC) prefix at Valley. Using Long Beach City College’s model, faculty in this department teach both reading and teacher preparation courses. This prefix is needed in order to create the Elementary Teacher Education AA-T, which is designed to create a pathway with CSUSB. The education courses were taught at SBVC approximately 15 years ago, but due to cutbacks, it was decided that the education courses would be taught at CHC, and the majority of the CD courses would be taught at Valley. Now, due to the teacher shortages, the EDUC courses are needed. Next Steps: The department will start building the EDUC courses in Meta.</p> <p>New ACCJC Standards - There are new ACCJC standards.
