VPI Report					
New Business	Changes will be effective Fall 2023. Academic Senate: Davena Burns-Peters spoke to the committee about program establishment and program				
	discontinuance. In the past, the Curriculum Committee was responsible for approving new programs. In looking at the role of Senate, curriculum is Senate's biggest responsibility. Authority has been assumed that the Curriculum Committee handled the process from start to finish, then it is sent to board. However, there is				



no process of bringing curriculum back to Senate. Davena asked at what point does the body as a whole have the opportunity to know and provide feedback into development of new programs?

- Janice Wilkins views the Curriculum Committee as an arm of the Academic Senate, the work that we do is viable and important on behalf of the college, the Curriculum Committee Chair has a standing spot on the Senate agenda in order to report out curriculum business.
- Mary Copeland mentioned that the ASCCC holds a 3-day conference each year where many laws and regulations, both locally and at the State are presented. Adding another step can delay the approval of curriculum if Senate needs to review.
- Dyami Ruiz-Martinez asked whether the current way was not working for there to be an extra step in developing programs? Davena noted that the Curriculum Committee is doing great work, but asked whether they representative enough of the campus that information is disseminated efficiently. Dyami commended that by adding additional steps, the student voice may be diluted.
- Matt Robles agreed that adding additional steps to the process may add more time. There seems to be a disconnect at how curriculum works across the campus and mentioned that we should open up the learning opportunities at how the process works, which may alleviate some concerns.
- Fernando Gomez recommended sending the Curriculum Committee minutes to the Academic Senate to review. This will ensure there is opportunity for members of the Senate to review and report out.

Bethany Tasaka wants the committee to focus on when new programs are written, what does the process look like at the campus and what role does curriculum play in that process?

Committee Meeting Dates for 2023 – 2024 Academic Year: Non-Instruction faculty are working on schedules now and shared the calendar for the 2023-2024 academic year. Mary Copeland mentioned that the Curriculum Committee meets every single Monday, so there is always an opportunity for all members of the Curriculum Committee to attend a curriculum meeting.

Shared Language for 098 and 222 Courses: Fernando Gomez reviewed Work Experience and Independent Study courses. We will now work to update templates to ensure they are accurate and compliant with curriculum standards.
