CD 111 Updates: At our last Curriculum Committee meeting, we approved CD 111 to include a lab component. After researching the requirements for CSUSB, the department has decided to remove the lab component to this course and replace it with 15 hours of observation written in the course description. This will more closely align the course to the C-ID and to CSUSB.			
Transfer Model Curriculum (TMC): Janice Wilkins spoke to the Curriculum Committee about the TMC processes. All TMCs start with the Articulation Officer, when any TMC degree is proposed, Janice completes a template and sends it to the Curriculum Coordinator to update in Meta. Janice makes sure all courses are approved in the different areas, so we are able to have more options for students and to remove barriers and allow them to transfer. In the next year, we will be going through a TMC degree audit to review the description, courses, and units for all TMCs. This audit is needed to make sure the degrees align with the new CalGETC.			
In the context of the Elementary Teacher Education AA-T degree, we had the option to add any CSU GE A3 course into List A and the department chose to only have READ 104 in that section and to remove ENGL 102 and PHIL from that list after the TMC was submitted to the Curriculum Coordinator to add to Meta. When it comes to developing Ed Plans and reviewing graduation requirements, Counselors look at the actual TMC template when evaluating to see if students have the requirements to graduate for those degrees, so if courses are removed from certain sections, students will be unable to use previously taken courses for that section, delaying their graduation/transfer.

	Dr. Humble asked when we can expect to hear about the decision for the READ 104 course and its approval for CSU GE area A3. Janice has sent three emails asking the CSUs when they expect to receive our approvals and we are still waiting to hear back. Jamie Herrera asked what it would mean if READ 104 doesn't get approved. If READ 104 is not approved, we would need to send the Elementary Teacher Education AA-T Degree back for board approval as a correction to add the courses in Area A3 that are approved. Elizabeth Banuelos asked if READ 104 would be offered to students every semester to ensure students are able to graduate on time. Denise Knight assured the Curriculum Committee that the READ 104 course will be offered every semester in every modality to help students.
Old Business	ETHS Webinar: Janice and Bethany attended a webinar on 05/05/2023. It was stated in the presentation that it is very unlikely for any new ETHS cross-listed courses to receive approval due to minimum qualification standards and the overall integrity of the ETHS disciplines. We have some new ETHS courses that represent 3 out of the 4 autonomous ETHS disciplines that will be reviewed today and a new degree.
Announcements and Public Comments	Denise Knight spoke to the Curriculum Committee about the Elementary Teacher Education AA-T Degree. At the end of last Week, there were a lot of rumors circulating about this. Denise received a phone call about the possibility of sending the Elementary Teacher Education AA-T Degree to vote to the Curriculum Committee at today's meeting and had heard about the Counseling Department possibly refusing to advertise this degree to students. All rumors are unfounded and the Elementary Teacher AA-T Degree will be moving forward for board and State approval with a Fall 2024 effective date.
