    - There was discussion regarding formalizing certain programs, such as Honors, as official programs rather than committees. Further updates are anticipated, and ongoing conversations were noted.

    - The committee discussed participation in College Council and the importance of aligning task force efforts with broader campus initiatives to support effective collaboration.

    - There was discussion regarding the current structure of College Council, including the roles of various members and the status of appointments. The committee also addressed how committee recommendations are integrated and emphasized the importance of transparent decision-making.

  - Survey analysis with respect to decision-making flow were reviewed. Recent updates in the College Council structure were discussed, along with comparisons of decision-making flowcharts from various community colleges.
  - The committee considered the development of a campus-wide flowchart, noting that this would help clarify processes for constituents. Steps discussed included:
  - Additional points included discussion about committee assignments and meeting schedules. It was suggested that visual aids and clear documentation of meeting times would benefit the campus community. It was also acknowledged that some committees, such as Scholarships, are no longer be part of participatory governance.
