Institution Set Standards

ACCJC is now looking at Institution Set Standards (ISS) differently. ISS are no longer considered the “floor” and ACCJC is looking for colleges to establish stretch goals. Colleges are receiving recommendations for improvement when their ISS aren’t challenging.

For instance

San Jacinto SP. 18

ACCJC Recommendation 1

In order to improve institutional effectiveness, the College should establish institution-set standards that provide more challenging benchmarks in pursuit of continuous improvement (I.B.3).

From the ISER

Mt. San Jacinto College has established Institutional Set Standards for various measures for assessing student success. These standards represent the floor for their respective data elements. A **six-year average** is analyzed and the set standard is established through a collaborative process through the College’s participatory governance structure.
