RSI Update	S. Lillard presented the campus-wide RSI (Regular and Substantive Interaction) Implementation plan, emphasizing its importance for accreditation and student success. She reviewed the development of the RSI policy, the creation of a detailed multi-semester timeline, and the launch of faculty-friendly DE addenda. The plan includes new professional-development resources, a best-practices guide, self-assessment tools, and an RSI mentoring program in which faculty mentor other faculty in a non-evaluative, supportive environment. A pilot of 30 online courses will begin in spring, eventually expanding to 54 courses for ACCJC review.
