<b>ISER Update</b>	Jeremiah Gilbert has completed the draft of the ISER and will distribute it to the Committee for review by this evening. Committee members are asked to review the draft and submit any feedback by Friday, February 27, 2026. The draft will then be shared with the campus community, including students, on Monday, March 2, 2026, for broader review and input. All campus feedback is requested by March 31, 2026.
<b>Accreditation Website</b>	The committee reviewed the updated Accreditation website, which now includes links to the 2027 Institutional Self-Evaluation Report (ISER), the ACCJC Comprehensive Review Timeline, the ISER Draft Review and Feedback Timeline for Spring 2026, and the Campus and Board Approval Timeline for Fall 2026. Additional links to supporting evidence for each standard will continue to be added, with completion anticipated by April.
<b>ISER Feedback – Form Review</b>	The committee reviewed the feedback form and identified areas for revision. The goal is to finalize the form and generate a QR code to facilitate campuswide feedback on the ISER.
